

2019 State Archery Tournament Information

When: Friday, March 22. The bus will leave the school at 12:30 PM. **If your child is not riding the bus, please let us know as soon as possible.** This will help us determine how many buses we need to take. A flight schedule is attached to this sheet. A pdf copy of the flight schedule is also posted on the Thunder Activities page on the March 22 date. Simply go to the March 22 date for archery and click on the pdf file to download it. Please look at this schedule so that you know when your child will be competing.

Where: State Fair Event Center, located at 2005 Burdick Expressway East in Minot.

Meals & Snacks: Concessions will be available at the tournament site. Archers will be responsible for buying their own lunch/snacks at the concession stand. Archers can also pack their own lunch/snacks if they don't want to purchase it at the concession stand.

Tournament Requirements:

- Wear your red Medina Archery shirt. If you don't have a Medina Archery shirt, please wear some other red clothing that represents our team colors (red & black).
- Please wear closed-toed shoes. Sandals, flip-flops, Crocs or other open-toed shoes cannot be worn during the tournament.
- Electronics may be used on the bus, and at safe locations at the tournament facility, but may not be used by archers while shooting in a flight.
- Make sure a liability waiver is signed and returned to Mr. Bosche. A waiver is attached to this sheet. It is also posted on the Thunder activities page. All archers must have a signed liability waiver to participate in the state tournament.

Behavior on Tournament day: All archers need to be respectful and on their best behavior throughout the day. Each archer is a representative of our school and community, so it is important to be respectful and courteous at all times.

Return Time: We will plan to return to Medina at approximately 10:30 PM. Please pick up your child promptly when we return. We will have students contact parents with a more exact return time when we leave Minot. Please make sure students have your contact information, so that they will be able to call you.
